# General Terms & Conditions (1/2)

***Once signed and returned to Two-Wheel Dreams, this agreement will allow you to register to the selected trip.***

## 1. Introduction

This agreement outlines the terms and conditions for participation in motorbike adventure trips organized by **2-Wheel Dreams**. By signing this agreement, the participant acknowledges and accepts the responsibilities, risks, and conditions detailed below.

## 2. Eligibility and Requirements

- Participants must hold a valid motorcycle license and be legally permitted to ride in the countries visited.
- Participants must provide proof of valid travel insurance covering medical expenses and repatriation. 2-Wheel Dreams can provide options or arrange it for you upon request.
- If using own motorbike, it must be properly insured and in roadworthy condition. Participants are responsible for maintenance, repairs, and road assistance during the trip.
- Participants must wear appropriate protective gear: helmet, gloves, riding suit, and boots.
- Participants have the option to rent a motorbike and/or protective gear via the organizer according to the available rental proposals.
- If renting motorbike or gear, the participant assumes full responsibility for any damage, loss, or theft.
- Insurance options may be available to waive or limit liability, subject to the terms of the chosen policy.

## 3. Safety Regulations

- Participants must adhere to all traffic laws and local regulations.
- Riding under the influence of alcohol, drugs, or any impairing substance is strictly prohibited.
- Reckless riding, dangerous overtaking, or behavior that puts others at risk will result in immediate exclusion from the trip without refund.
- In case of an accident, participants must follow emergency procedures and notify the trip leader immediately.

## 4. Responsibilities of Participants

- Follow the trip leader and designated route and trip schedule unless otherwise agreed.
- Cooperate with the trip leader and respect other riders.
- Assume financial responsibility for fines, damage, or injuries resulting from their own actions.
- Notify the organizer of any health conditions that may affect their ability to participate.





# General Terms & Conditions (2/2)

## 5. Rights of the Organizer

- The organizer reserves the right to modify routes, schedules, or accommodations due to weather, safety concerns, or unforeseen circumstances.
- The organizer may refuse participation to any rider who fails to meet safety requirements or violates the agreement.
- The organizer is not liable for personal injury, property damage, or loss suffered during the trip.
- The rented bike and/or gear are under sole responsibility of the participant.

## 6. Payment and Cancellation Policy
